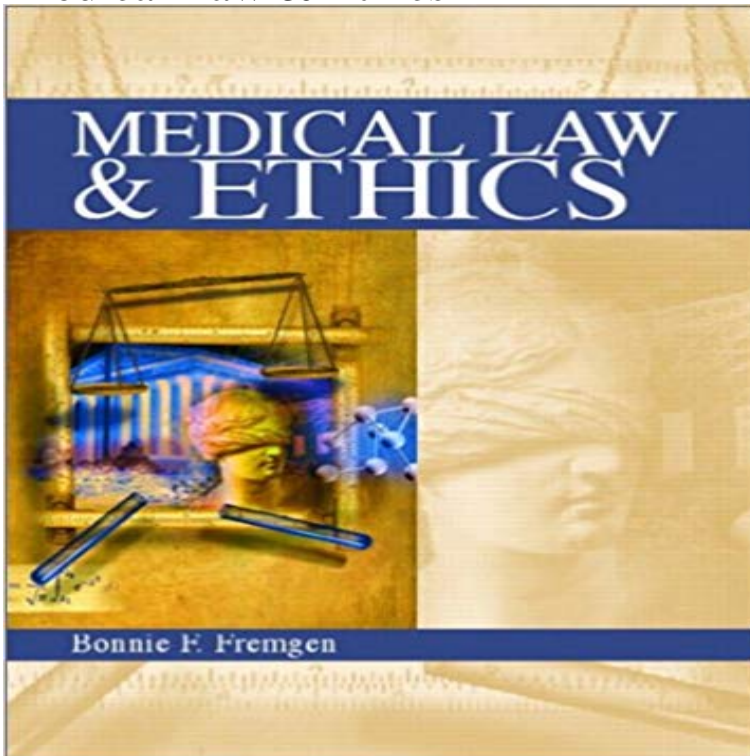


## Medical Law & Ethics
