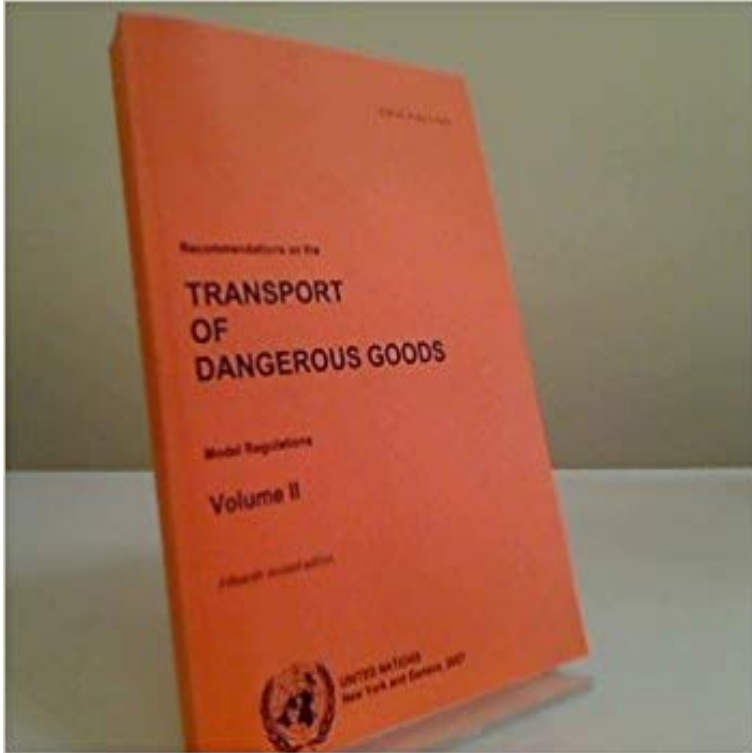


Recommendations on the Transport of Dangerous Goods (Volume 2)
